Chief of the Homicide Bureau, District Attarney's Office, will address the Men's Club concluding meeting of the season on, "BEHIND THE SCENES OF FAMOUS CRIMINAL CASES"



#### JACOB J. ROSENBLUM

One of the Chief Assistants and presently Chief of the Homicide Bureau, District Attorney's Office. Formerly Chief Assistant to Thomas E. Dewey during the Racket Investigation, and prior to that time as Assistant United States Attorney for the Souhern District of New York tried several of the most important cases, which included the conviction of Joseph W. Harrison, the banker, and the longest criminal jury trial which resulted in the conviction of thirteen defendants.

As Chief of the Homicide Bureau personally has prosecuted nineteen men charged with the crime of murder in the first degree. Each of the defendants was convicted of that crime and all nineteen convictions were sustained by the Court of Appeals.

He tried two defendants who were responsible for kidnapping Arthur Fried, and invoked a kidnapping statute never previously used, which enabled him to obtain the death sentence although there was no corpus delicti.

He recently convicted Leo J. Alexander, after a nine week trial, for operating a firetrap in Chinatown. Defendant received a sentence of 3 to 6 years.
