WRITE TO THE PRESIDENT AND SECRETARY OF STATE

The report submitted by the United Nations Special Committee on Palestine is now being discussed at Lake Success. The fate of Palestine as a Jewish homeland will depend upon the decisions reached there. Thus far we are informed that our State Department has not made up its mind as to what course to follow.

In accordance with the democratic process, it is our duty as American citizens to make our wishes known to our government on this all important matter at this critical juncture. We ask every member of the congregation to write or wire President Truman and Secretary of State Marshall, asking them to instruct the American delegates to the United Nations to support the majority report of UNSCOP. In writing to them, the following points should be stressed:

Every president since Woodrow
 Wilson endorsed the historic

rights of the Jewish people over Palestine.

- 2. In two resolutions the Congress of the United States is on record endorsing the establishment of a Jewish homeland in Palestine
- 3. Both major parties in their platforms asked for the establishment of a Jewish commonwealth in Palestine.
- 4. The only solution to the problems of Jewish homelessness especially for the hundreds of thousands of suffering jews in Europe, is Palestine.

Do not delay this important matter. Write or wire at once! The message to the President should be addressed to the White House and the one to Secretary of State Marshall to the American Delegation to the United Nations, 2 Park Avenue, New York City.
