REMEMBER THEM IN THE BOOK OF REMEMBRANCE

Several weeks ago, the Bulletin carried an article announcing the forthcoming publication of the Book of Remembrance. In that article, the purpose of the Book of Remembrance was set forth, as being consistent with the Yizkor prayer in which a pronouncement of a pledge for charity is made. This, then, affords our worshipers an opportunity of fulfilling this pledge, by submitting names for the Book of Remembrance which is published before Shevuoth and placed in the hands of

our worshipers during the four times **NEW ASSOCIATE TRUSTEES** of the year when Yizkor is recited.

Our past experience has shown that a number of our members and friends have felt hurt and disappointed because the name of a dear departed one did not appear. Particularly is this so when the Books are distributed during Yizkor and the Memorial Prayer is recited, and a special prayer is said for those whose names are recorded.

The names which appear are submitted to the office. No name is recorded on the strength of a previous listing. Only when we are authorized to include the name of your dear departed one do we do so. It is therefore important that we have your authorization; otherwise we cannot include any names in this Book of Remembrance.

The Book is now being readied for press. Since it appears before the Shevuoth festival, which will be on June 3rd and 4th this year, we must have all names by Wednesday, May 25th. For your convenience, a special form appears on page 4.

JUDGE ROTHENBERG SPEAKS AT MEN'S CLUB DINNER George Jacobs Named Father of the Year

For the ninth consecutive year, members of the Men's Club gathered this past Tuesday evening to participate in the Annual Dinner of the group. A large number of guests was on hand to enjoy one of the finest dinners ever to be held.

As guest speaker, the Men's Club had Judge Morris Rothenberg, President of the Jewish National Fund, who spoke on "The Implications of the Jewish State." Judge Rothenberg's talk was not a formal address, but, as he put it, an expression of his feelings on the establishment of Israel and its effects on the nations of the world. Pointing out that a true appraisal of this momentous event cannot yet be given, the Judge presented certain changes which, he felt, would of necessity come about now that Israel is one of the recognized nations. In the first place, he said, the Jew will no longer be obliged to journey from country to country, hat in hand, begging for admittance. He now has a land which will welcome him and give him an opportunity to live without fear of again having to migrate.

Secondly, Judge Rothenberg continued, the psychological effect of Israel's nationhood will manifest itself with every new day. It has, in fact, already been seen, where Israeli statesmen are welcomed among the representatives of the other nations at sessions of the UN. For the first time, the Jew will be viewed as a member of an identifiable people, an entity in itself.

Judge Rothenberg's remarks were most warmly received, containing as they did not only an interesting expression of an intelligent viewpoint, but also humorous anecdotes from the personal experiences of one who has been actively connected with Jewish life for so many years.

Prior to the talk of Judge Rothenberg, Mr. Ira F. Weisman, president of the Men's Club, presented several checks, constituting the major benevolences of the group, to the Congregation Building Fund, the scholarship funds of Ramaz and the Religious School, and the Camp Fund which sends deserving children to camp during the summer months.

An interesting feature of the evening was the drawing of a charcoal sketch by the noted artist, David Immerman, as a door prize. The winning ticket was held by Dr. Frank Goodman, who made an excellent subject for the deft strokes of the artist's chalk. Mr. Immerman again had several oil paintings on exhibition around the Social Hall.

Mr. Weisman announced the designation of Mr. George Jacobs as the Father of the Year. An appropriately inscribed certificate will be awarded Mr. Jacobs at Father's Day Sabbath, June 18th, in a brief ceremony in our Synagogue. We feel that this is an honor Mr. Jacobs richly deserves in light of his devotion to our institution and the tireless efforts he expended in its behalf during the past few years.

The evening was brought to a close with the humorous antics of Irving Kaufman, well known radio artist, who entertained with original songs as well as with nostalgic melodies which he introduced years back.

CHIEF RABBI HERZOG ATTENDS K. J. SYNAGOGUE SERVICE

It was a thrilling moment—indeed a rare privilege—when, at services last Sabbath morning, Chief Rabbi Isaac Halevi Herzog entered the Synagogue to worship with us. The Chief Rabbi, who is in the States for a brief visit, walked a considerable distance in order to attend our services.
