

DR. IRVING GREENBERG TO DISCUSS "HALAKHIC PERSPECTIVES ON WAR IN THE MODERN AGE" on Wednesday, February 1st

The third lecture in the series "Traditional Judaism Confronts Contemporary Social Issues" will be delivered by Dr. Irving Greenberg on Wednesday evening, February 1st, at 9:10 p.m. The occasion will mark the opening of the spring semester for our Wednesday evening adult education classes which will meet at 8:00 o'clock on 9 Wednesdays from February 1st through April 5th (omitting February 22nd). The lecture will be entitled: "Halakhic Perspectives on War in the Modern Age."

The unabating furor over our country's military involvement in the Far East is a life and death issue which affects us all, directly and indirectly, practically and ideologically.

We are confronted by a conflict between our unalterable opposition to certain political and militaristic forces on the one hand, and our concern for the sacred character of human life on the other. Do we have the moral right – not to mention the problem of political wisdom — to intervene at all in a political upheaval in Vietnam? If we do have that right, are we justified in unlimited escalation or is there some point at which improper means render otherwise justifiable ends improper?

To what extent may military targets be attacked if this entails the destruction of non-military targets: civilian life, crops, homes, etc? Must we seek every possible means — including cessation of bombing — in order to achieve a rapproachment with the enemy? Is this the kind of enemy with whom we must — or even may strive to establish such a rapproachment?

These are questions which trouble – or should trouble – every thinking American, young and old. To be sure, there are answers to all of these questions on the basis of power politics answers which may differ depending upon one's political orientation.

The Jew, however, must face these questions from the resources of his own frame of moral values. Normative Judaism does have something to say about each of these questions, although, admittedly, there will be differences of opinion on how to apply Jewish sources to the questions.

Our lecture on February 1st is an attempt to relate Traditional Judaism to this most crucial of modern problems. We are fortunate in having a brilliant, young exponent of Traditional Judaism who will present his findings on this subject. Dr. Greenberg, who holds the Ph.D. degree from Harvard in history, is on leave from Yeshiva University's faculty of Social Science. He is at present the Rabbi of the Riverdale Jewish Center. He has won considerable recognition — and criticism — for his bold and creative application of Judaism to both religious and general problems. His brilliant analysis of our lecture subject was the highlight of a recent conference on Vietnam sponsored by the Synagogue Council of America.

"Did Pharaoh Have Free Will?"

Judaism, as a religion and as a philosophy, accepts the view that man has free will to determine his own behavior. We read in this week's portion, however, that "God hardened Pharaoh's heart" and, in effect, made him reluctant to free the Jewish people from Egyptian slavery.

Two questions immediately come to our mind: First, if man has free will, was Pharaoh's behavior free or determined by God? Second, if Pharaoh's will was determined by God, how could he have been held accountable for his behavior and punished for his failure to free the Jewish people?

The answer to the first question essentially is found in the dynamics of free will as Jewish philosophy understands it. Man is free to choose alternate courses of action, not because God cannot determine man's behavior, but rather because God allows man free decision. God is omnipotent and therefore can determine everything. He restrains his power in the case of man, however, and permits man free choice.

According to this view, God could always withhold the power of free choice from a man by exercising His full omnipotence. This is what God does with Pharaoh in order to demonstrate to the world through the Ten Plagues that God's providence is con-tinuous and unending. Why then is Pharaoh punished for his intransigence when it was God who determined his behavior? The answer to this question is to be found in a basic philosophical idea called "The Doctrine of Agreement." According to this Doctrine, even if man's behavior is determined by an external force, man may be held accountable for his behavior if he follows an evil or good pattern with full agreement.

For example, if a starving man steals, one might argue that his criminal act is caused by external environmental conditions. Philosophically, his behavior is determined, but he could still be held accountable for it if he stole with enthusiasm and without a sense of guilt. In other words, while his bad behavior is determined by external forces, his mood and method are motivated by his own lack of a sense of guilt. He is punishable not for the external determined act but for the free internal agreement and acceptance of the act.

This concept is extremely important in analyzing various forms of errant and criminal behavior. It is because of this view that many Germans in the 30's and 40's could be held accoun-

AM HASEFER GROUP DISCUSSES FROMM BOOK

A large group of members of our Am haSefer program — more than 30 in all — gathered recently in the home of Rabbi and Mrs. Haskel Lookstein for the opening discussion meeting of the year. The book under discussion was "Psychoanalysis and Religion" by Dr. Erich Fromm.

Our esteemed member, Dr. Mortimer J. Blumenthal, presented a review of the book and raised many interesting questions. A rather spirited discussion took place on the following matters, among others:

1. Is authoritarian religion essentially divorcible from humanistic religion? Is it possible to reach the goals of love, brotherhood, justice, truth, etc., without some sort of authoritarian framework?

2. Are the above goals of humanistic religion necessarily the sole preoccupation of a religious personality? Does not a religious personality have the opportunity for a fuller realization of his human potential than does a secular humanist?

3. Is it possible to clearly differentiate psychoanalysis as a means for adjustment from psychoanalysis as a means for "curing the soul"? If such a differentiation is possible, is the latter necessarily to be preferred over the former, as Fromm implies?

We are extremely grateful to Dr. Blumenthal for serving as an excellent resource in the discussion of a book which has wide ramifications in many areas of modern life and thought, not the least of which is the area of religion.
