# AN URGENT REQUEST CONCERNING HIGH HOLY DAY SEATS

The High Holy Day season will officially be ushered in on Saturday night, September 14th, with the midnight Selichoth service. Unofficially, however, High Holy Day activity has been the main pre-occupation at Kehilath Jeshurun for some time.

Worshippers and new members of the community, anxious to make arrangements for High Holy Day seating, are regular visitors at the synagogue office. As always, a warm and friendly office staff is available to serve their needs.

#### Your Cooperation is Needed

Members of the congregation received notification concerning High Holy Day seats during the early part of the summer. Some members have not yet responded. There is no way of our knowing, therefore, whether it is their intention to worship with us during these coming High Holy Days.

We urge our members to kindly notify the synagogue office without delay of their intentions for worshipping with us. We assure them that every effort will be made to satisfy their requirements and those of their families.

Regular worshippers and newcomers in the community are invited to make their reservations as soon as possible. A warm welcome awaits you.

# MAIN SYNAGOGUE REDECORATED

Our worshippers will be delighted with the appearance of our Main Sanctuary. It has been rendered even more beautiful and impressive than it was. All the ugly scars which were beginning to annoy our worshippers have been removed and our House of God stands forth now in all of its beauty and glory.

Within several days, all the window frames of the ladies' section will be replaced by new aluminum frames. This will not only improve the appearance of our stained glass windows, but it will eliminate winds and drafts about which the ladies used to complain.

Other improvements of a basic nature are contemplated, and they will

probably be effected during the course of the year. The cost of the improvements already made is in the neighborhood of \$50,000. Additional improvements will involve additional costs.

We know that our congregants want to be informed about this. As they are approached for the Annual Synagogue Appeal, we are confident that they will have in mind the greater needs of the congregation this year because of the expenses incurred.

During the summer, services were temporarily held in the Auditorium of the Synagogue House. We will be able to move into the refurbished Main Synagogue next Saturday.

# KEHILATH JESHURUN DURING THE SUMMER

Kehilath Jeshurun is an all-year-round synagogue. Summer and winter our religious services go on with undiminished regularity. During the summer months, the attendance at Sabbath services rarely fell below one hundred and fifty. The daily services in the Chapel held up beautifully mornings and evenings.

We hardly had to resort this summer to any outside help in order to maintain the daily Minyan. This is a tribute to many members of our congregational family who came to "help out" in order to make sure that their fellow members had a Minyan.

The Tisha B'Av service was held in the Auditorium of the Synagogue House, where public worship was conducted while the Main Synagogue was being refurbished. On Saturday night, at the reading of Lamentations, the Auditorium was comfortably filled with worshippers. On Saturday morning, as well as at Mincha in the afternoon, the attendance was remarkable.

To paraphrase an old song — Kehilath Jeshurun is as lovely in August as it is in May.

# THE WEEKLY PORTION

#### KI TETZE

"Do Not Judge God"

This week's portion contains, among its many mitzvot — it has the greatest number of all the weekly portions — the famous rule of "kan tzipor." This provides that if one walks along the way and finds a bird's nest, he may take the young birds only after chasing away the mother.

Various commentaries consider the aim of this mitzvah to be the teaching of mercy. As the Netziv (Rabbi Naphtali Zvi Yehudah Berlin, head of the Yeshiva in Wolozin) explains, this is an example of measure for measure. The mother could easily have flown away. She remained behind only to protect her young from danger. Because of her mercy we must show mercy to the mother by sparing her the grief of seeing her young taken.

Following this explanation, the Netziv adds, enigmatically: "Nevertheless this is nothing more than a decree." It would appear that after having offered a rational explanation for this mitzvah, thus attributing it to the "wisdom" of God, the Netziv then reverses himself and declares the mitzvah to be an arbitrary manifestion of the "will" of God.

Actually this is not so much a reversal as an halakhic "hedge", so to speak, for which there are several reasons.

First, the rationality of the law is itself open to question. If mercy is indeed the object, then why allow man

even to take the young birds. The act of killing living things for food is essentially unmerciful — for which the community of ethically motivated vegetarians is ample testimony.

Second, even such an obviously rational law has arbitrary elements in it. If the man is sufficiently hungry, and he is forbidden to take the mother bird from the nest, then the mitzvah is readily seen as a manifestation of God's will rather than an outgrowth of His reason (Another example of this ambivalent attitude toward the law might be the case of the starving poor man who must steal in order to eat).

Finally, the Talmud implies that ascribing this law to God's mercy opens the Pandora's Box of the problem of human tragedy in the world. If God is merciful toward the bird, then why do the righteous suffer. The late Milton Steinberg in his memorable book, "As a Driven Leaf" vividly portrays the disintegration of one man's faith when he saw a small boy fatally injured as a result of his efforts to perform the mitzvah of "sending the mother away" scrupulously.

Thus the unequivocal judgment of God's wisdom in His Law can lead to the judgment of His conduct of the universe. Therefore, having offered a tentative interpretation of this mitzvah, the Netziv hedges and says: "Nevertheless, this is nothing more than a decree."
